- / Tuition \$320 per child. A \$75 nonrefundable deposit is required to hold your space. Balance of \$245 due May 1.
- / You can pay with a check or online, and either snail mail or scan/email this completed registration form. (To pay online, visit www.owensfarm.com)
- / Upon receipt of deposit, we will send confirmation and health form. All campers are required to verify that they have had a physical within 2 years prior to the start of camp.
- / **The balance and completed health form are due on or before May 1.**
- / CANCELLATION/REFUND POLICY: There are no refunds or reductions after May 1 unless a) we are notified at least 3 weeks before camp AND b) are able to fill your space. If those two conditions are met, tuition will be refunded minus the nonrefundable deposit, resulting in a \$245 refund. *You are, however, welcome and encouraged to transfer your space to another child if your child is unable to attend.*
